All applications are subject to review by the Teller-Park Conservation District Board of Supervisors. Deadline for submission is October 15, 2023. Funds are limited and will be issued on a first-come, first-serve basis.

Cost Share Policy

Teller-Park Conservation District will reimburse landowners at a 50/50 rate up to a maximum of \$400 and only for weeds listed below. Reimbursement is for cash expenses (in-kind services do not qualify). Both contract labor and chemical expenses are eligible for cost-share reimbursement. Only CO Dept of Agriculture approved treatment methods are eligible for cost-share program. TPCD reserves the right to fund larger projects at more than \$400 upon board approval. All mapping data will be recorded to EDDMapS as required by Colorado Department of Agriculture.
